Abstract

Your paper must contain an abstract with a maximum of 500 words. The abstract should contain the objective of the paper, the methodology used to solve the problem and the results achieved. Submissions to the entrepreneurship competition should also emphasise the innovative aspects, the viability, and the potential impact of the proposal. Abstracts should be submitted in Word/.doc format using the *Leading* platform

(<https://congressos.leading.pt/geral/inserirresumo.aspx?evento=260&formulario=613&lingua=en-GB>).

Abstracts should be no longer than 2 pages and have a maximum of 500 words, with no references, images, or pictures.

Keywords: Include up to 5 keywords complementing the title and abstract, separated by semicolons

CONGRESS PUBLICATIONS (INFO)

Accepted abstracts will be edited and published as a **Book of Abstracts** (max. 2 pages) of the Open Access Series “Coleção Ativos de Engenharia” (Engineering Assets Collection).

Full-length papers (max. 18 pages) of selected top-quality research and industry manuscripts can be published in:

- English: **Engineering Asset Management Review** (EAMR), Springer Book Series (Scopus and EI Compendex).
- Portuguese/Spanish: **Revista Ativos de Engenharia** (RAE), Ponteditora Open Access Journals (Scopus indexation ongoing).

Selected contributions to the entrepreneurship competition can be published in a special issue:

- English/Portuguese/Spanish: **Journal of Entrepreneurial Researchers** (JER), Ponteditora Open Access Journals (Scopus indexation ongoing).

1. Introduction

(Suggested chapters: Introduction; Literature review; Methodology; Results and Discussion; Conclusions. The title and structure of papers may vary according to the nature of the investigation. For example, entries for the entrepreneurship competition should include information about the team involved, the problem to be addressed, and the proposed solution, as well as the project's relevance in the context of CongrEGA).

NOTE:¹

Manuscripts should be no longer than 6 pages (including references and appendices). A non-edited version of all submitted manuscripts will be distributed to all registered participants.

Selected manuscripts can be extended up to 18 pages and undergo peer and editorial review for full-length paper publication in Engineering Asset Management Review or Revista Ativos de Engenharia (Journal of Engineering Assets).

Illustrations, such as figures, graphs and tables must be prepared according to APA standards, together with captions, credits and source. If there are illustrations imported from other programs, such as Excel and Power Point, also send the source file.
